

Agrosafe App Privacy Policy

Project Box, LDA., responsible for processing data from the Agrosafe application, undertakes to respect and protect the information granted to it in accordance with the General Data Protection Regulation (Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016) on the protection of natural persons with regard to the processing of personal data and on the free movement of such data.

What personal data do we collect?

To use our application it is necessary to create an account. In this case, the minimum necessary personal data to be provided are the e-mail address and username.

How do we use the information we collect?

The e-mail address is used to create an account, log in and may be used to contact the user, in this case only if necessary.

The username is used to create an account and to use the application's features, such as managing tasks and registering a vehicle's daily activity. The purpose of collecting the name is to identify the person in charge of a task and the driver of a vehicle, so that, in the event of an accident or medical emergency, it can signal and alert the competent authorities and list of emergency contacts.

None of the personal data is disclosed outside the application.

When using the Agrosafe app, the user accepts and recognizes that he will have to provide his personal data, name and email, strictly necessary for the provision of its functionalities; such data will be used exclusively for the aforementioned purposes.

Personal data controller

In fulfilling its responsibilities, and in accordance with the provisions of the General Data Protection Regulation, Project Box, LDA. notify the National Data Protection Commission (CNPD) whenever it becomes aware of any breach of personal data under its responsibility.

Third parties

Project Box, LDA., in compliance with the General Data Protection Regulation, may transmit personal data under its responsibility to third parties. In these cases, Project Box, LDA. will only resort to entities that provide sufficient guarantees to implement the appropriate technical and organizational measures so that the treatment meets the requirements of this Privacy Policy and ensures the protection of the data subject's rights.

How can the holder of personal data manage, update and delete their information?

At any time, the holder of personal data may request Project Box, LDA., regarding the data it has, to update them or request their deletion.

This request must be sent to privacy@projectbox.pt.

However, whenever there is a data retention period imposed by law, Project Box, LDA. reserves the right not to carry out the request of the holder of the personal data, informing him of the respective reasons.

Rights of holders of personal data

The data subject has the right to request Project Box, LDA., privacy@projectbox.pt:

- Access, under the terms and conditions provided for by law, to the user's personal data that are subject to processing;
- Rectification or updating of inaccurate or outdated personal data relating to the user; The processing of missing personal data when these are incomplete;
- Deletion, in cases specifically provided for by law, of personal data relating to the user:
- The limitation, under the conditions provided for by law, of the processing of personal data relating to the user;
- and also to withdraw consent given when data processing is based on consent only;

- Oppose processing for reasons related to your particular situation when data processing is based on the legitimate interest of the controller or a third party.
- The user may also request more detailed information from the appointed Data Protection Officer, namely on the purposes, grounds for lawfulness and conservation periods, as well as submit complaints about the way in which their personal data is treated, without prejudice to being able to also do so with the competent authority.

Final dispositions

Project Box LDA. may, without prior notice, change this Policy due to the need to adapt it to any legislative changes or recommendations from the CNPD.
